

RESOLUTION NO. 42-2006

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF BENSON, ARIZONA, ADOPTING A NOTICE OF INTENTION TO INCREASE WATER CONNECTION SERVICE FEES FOR UNESTABLISHED SERVICE CONNECTIONS AND CONFIRMING THE PREVIOUS DECLARATION OF **"THE CITY OF BENSON JUNE 2006 WATER CONNECTION RATE STUDY FOR UNESTABLISHED SERVICE CONNECTIONS"**, DATED JUNE, 2006, AS A PUBLIC DOCUMENT AND SETTING **OCTOBER 9, 2006**, AS THE DATE FOR PUBLIC HEARING ON THE PROPOSED WATER CONNECTION SERVICE FEE RATE INCREASE.


WHEREAS, the Code of the City of Benson requires that its water rates generate sufficient revenue to equal the cost of providing water services to its customers and the water rates currently in effect are insufficient to satisfy the requirement of generating sufficient revenue to equal the cost of providing said water services; and,

WHEREAS, in accordance with **A.R.S. §9-511.01**, the City of Benson has prepared a written report supplying data supporting the proposed water connection service fee rate increase, said report being entitled **"The City of Benson June 2006 Water Connection Rate Study for Unestablished Service Connections"** dated June, 2006, which was declared by the Mayor and Council of the City of Benson as a public document on June 26, 2006 and has been available for public inspection in the Office of the City Clerk since June 27, 2006.

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL as follows:


1. This Resolution shall serve as a written notice of intention to the public that the City of Benson intends to increase water connection service rates; and,
2. The written report entitled **"The City of Benson June 2006 Water Connection Rate Study for Unestablished Service Connections"** dated June, 2006, is hereby confirmed to be a public document and three (3) copies of such have been on file for public inspection in the Office of City Clerk as of **June 27, 2006**; and,
3. A public hearing on the proposed water and wastewater rate increase shall be held during the regular **City Council meeting at 7:00 p.m. on October 9, 2006**, at the Benson City Hall located at 120 W. 6th Street, Benson, Arizona.


