

RESOLUTION 28-2011

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BENSON, ARIZONA CANVASSING, DECLARING, AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 8, 2011

WHEREAS, on the 8th day of March, 2011, a primary election of the qualified electors of the City of Benson, Arizona was held for the purpose of electing one (1) mayor for a two year term and three (3) councilmembers to each serve four year terms; and

WHEREAS, the election returns, attached hereto as Exhibit A and incorporated herein by this reference, have been presented to and have been canvassed by the Mayor and City Council; and

WHEREAS, the election returns as canvassed show that there were 720 ballots cast; and

WHEREAS, the number of votes cast for each candidate is as follows:

WHEREAS, pursuant to Arizona law and the Benson City Code, Chapter 2, Article 2-3, Sections 2-3-3 and 2-3-4, at the Primary Election the candidate receiving a majority of all votes cast for the office of Mayor and the candidates receiving a majority of all votes cast for the office of Councilmember shall be declared to be elected to the offices of Mayor and Councilmember; and

WHEREAS, it appears that Toney D. King, Sr. received a number of votes constituting a majority of all the valid ballots cast for the office of Mayor and should be elected; Christopher Moncada received a number of votes constituting a majority of all the valid ballots cast for Councilmember and should be elected; Al Sacco received a number of votes constituting a majority of all the valid ballots cast for Councilmember and should be elected; and

WHEREAS, there is one remaining office of Councilmember that was not filled by a number of votes constituting a majority of all the valid ballots cast.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Benson as follows:

SECTION 1. That the total number of ballots cast at the primary election was 720.

SECTION 2. That Toney D. King, Sr. is declared to be elected to the office of Mayor effective as of the date of the General Election; Christopher Moncada is declared to be elected to the office of Councilmember effective as of the date of the General Election; and Al Sacco is declared to be elected to the office of Councilmember effective as of the date of the General Election.


SECTION 3. That there is one remaining office of Councilmember to be elected, therefore the General Election will be held on May 17, 2011.




