

## RESOLUTION NO. 55-2008

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BENSON, ARIZONA CANVASSING, DECLARING, AND ADOPTING THE RESULTS OF THE SPECIAL RECALL ELECTION HELD ON SEPTEMBER 2, 2008.

WHEREAS, on the 2nd day of September, 2008, a special recall election of the qualified electors of the City of Benson, Arizona was held for the purpose of electing two (2) Councilmembers to serve the remainder of the terms of office held by Councilmembers Dianne Tipton and Kathy Suagee; and

WHEREAS, pursuant to A.R.S. § 19-216, the candidate receiving the largest number of votes shall be declared elected for the remainder of the term of office; and

WHEREAS, the election returns, attached hereto as Exhibit A and incorporated herein by this reference, have been presented to and have been canvassed by the Mayor and City Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Benson as follows:

SECTION 1. That the total number of ballots cast at the special recall election was 915.

SECTION 2. That the number of votes cast for each candidate were as follows:




