

RESOLUTION 10-2016

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF BENSON, ARIZONA, AUTHORIZING THE RELEASE OF ASSURANCES FOR THE SUBDIVISION KNOWN AS COTTONWOOD HIGHLANDS LOTS 1 THROUGH 85, INCLUSIVE AND COMMON AREAS A, B6 THROUGH B9, INCLUSIVE AND C1 THROUGH C3, INCLUSIVE

WHEREAS, the subdivision known as Cottonwood Highlands, located within the City of Benson, has been recorded in the Office of the Cochise County Recorder at Book 15 of Maps and Plats, pages 25, 25A, 25B, 25C, 25D, 25E and 25F (hereinafter "Subdivision"); and

WHEREAS, due to the transfer of title of the Subdivision from the previous owner to Whetstone Partners, L.L.P., an Arizona Limited Liability Partnership ("Owner"), a new trust assurance agreement under Trust No. 70900369 between Owner, City and Pioneer Title Agency, Inc., which provides assurances required by A.R.S. §9-463.01 for the completion of Subdivision improvements, has been executed and approved by City; and

WHEREAS, the City desires to release the previous third party trust that had provided assurances of subdivision improvements under Trust No. 00953841 as no longer necessary or useful.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Benson, Arizona, that the third party trust under Trust No. 00953841 that provided assurances of subdivision improvements for Cottonwood Highlands, Lots 1 through 170, inclusive and Common Areas A, B1 through B9, inclusive and C1 through C3, inclusive is hereby released and the City Manager is authorized to execute all necessary documents to effect this release.


