A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF BENSON, ARIZONA, AUTHORIZING THE ACCEPTANCE OF A GOVERNOR'S OFFICE OF HIGHWAY SAFETY GRANT TO FUND EQUIPMENT PURCHASES AND OVERTIME

WHEREAS, the Governor's Office of Highway Safety (GOHS) administers a grant program to provide funding to local municipal police forces to enable them to acquire necessary equipment and fund overtime that will allow the local law enforcement agencies to better meet the goals of this program; and

WHEREAS, this grant program requires no matching funds; and

WHEREAS, the Chief of Police applied for a no-match Governor's Office of Highway Safety grant to fund the purchase of additional equipment and fund overtime involved in meeting the goals of this program.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Benson, Arizona, that the Chief of Police is hereby authorized to accept a Governor's Office of Highway Safety grant for additional equipment and overtime, complying with all required grant terms and conditions and the Interim City Manager is authorized to execute the GOHS Contract Number 2019-AL-037, attached hereto as Exhibit A.
