

RESOLUTION 15-2014

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF BENSON, ARIZONA, CANVASSING, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL ELECTION HELD ON MAY 20, 2014

WHEREAS, on January 29, 2014, the City Clerk of the City of Benson, Arizona, officially filed Recall Petition 2014-01 and did cause to be submitted to the qualified electors of the City at a special recall election held in and for the City of Benson on the 20th day of May, 2014 for the purpose of electing one (1) Councilmember to serve the remainder of the term of office held by Jeff Cook; and

WHEREAS, pursuant to A.R.S. §19-216, at a recall election, the candidate receiving the highest number of votes cast for the office of Councilmember shall be declared to be elected to the office of Councilmember for the remainder of the term of office; and

WHEREAS, on the 20th day of May, 2014, a special election of the qualified electors of the City of Benson, Arizona was held for the purposes of electing one (1) councilmember; and

WHEREAS, the election returns, attached hereto as Exhibit "A" and incorporated herein by this reference, have been presented to and have been canvassed by the Mayor and City Council; and

WHEREAS, the election returns as canvassed show that there were 844 ballots cast and were cast as follows:

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Benson as follows:

SECTION 1. That the total number of ballots cast at the special recall election was 844.

SECTION 2. That Jeff Cook is found, determined and declared of record to receive the majority of the total number of valid votes cast and is hereby retained in office.

SECTION 3. That all orders or resolutions in conflict be and the same are, to the extent of such conflict, hereby repealed, and that this resolution be in full force and effect immediately upon its adoption.






