**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF BENSON,
ARIZONA, APPROVING A SCHEDULE FOR FEES RELATING TO RECREATION
SERVICES**

WHEREAS, Article 16-2 of the City Code directs that the City Council via Resolution adopt appropriate fee schedules for Recreation services.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Benson, Arizona, that the proposed fee schedule for Recreation services, attached hereto as Exhibit "A", is hereby approved, effective immediately.

FEE SCHEDULE

A.	Swimming General Admission includes wading pools.	13 and up \$1.25 12 and under \$.50
B.	Adult Swim 18 and up.	\$1.25
C.	Swim Lessons per two week session; per participant ages 5 and up or as skill level permits	\$20.00
D.	Swim Lessons infant and toddler per four week session; per participant age infant to 4 years old or as skill level permits	\$10.00
E.	Season Swimming Passes- Summer season only, from opening day till closing day.	18 and up - \$30.00 17 - 13 years old - \$ 20.00 12 and under - \$10.00 Family- \$ 40.00 2 Adults/2 Children each additional child same family \$ 6.00
F.	<p>Pool Rental Rate - Pool rental for private group use and non-profit private use. Minimum two hours rental plus as additional cleaning deposit. Lifeguards are mandatory and included in the rental fee</p> <p><u>Refunds - Cancellations from two (2) weeks (14 days) prior to the reservation date will receive a full refund. Cancellations made no less than two (2) days prior to the reservation date will be given a refund of 50% of the rental rate. Refunds will not be given for cancellations made less than (2) days prior to the reservation date or after the reservation date has occurred. The afore mentioned applies to rescheduling reservation date.</u></p> <p><u>A Refund will be given in the event of inclement weather in the following manor: Reservations cancelled by City staff one hour or less prior to start time of the reservation will be given at 100% percent of the rental fee. Reservations cancelled by City staff thirty minutes or more after the start time of the event will be at a rate of fifty percent of the total rental fee.</u></p>	<p>\$50.00 an hour \$ 100.00 cleaning deposit</p>
G.	<p>Recreation programs and camps as scheduled by the Recreation Department will be determined on a per camp/program; per participant basis as the City Manager and Recreation Department find necessary to adjust based on program expenses.
