

RESOLUTION 35-2011

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF BENSON, ARIZONA, CANVASSING, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 17, 2011

WHEREAS, on the 17th day of May, 2011, a general election of the qualified electors of the City of Benson, Arizona was held for the purposes of electing one (1) councilmember to serve a four year term and presenting Proposition 401, a referendum of Ordinance 550, and Proposition 402, a franchise agreement between the City of Benson and Sulphur Springs Valley Electric Cooperative, Inc., to the voters; and

WHEREAS, the election returns, attached hereto as Exhibit A and incorporated herein by this reference, have been presented to and have been canvassed by the Mayor and City Council; and

WHEREAS, the election returns as canvassed show that there were 717 ballots cast; and

WHEREAS, the votes cast were as follows:

WHEREAS, pursuant to Arizona law and the Benson City Code Section 2-3-3, at the General Election the candidate receiving the highest number of votes cast for the office of Councilmember shall be declared to be elected to the office of Councilmember; and

WHEREAS, it appears that Ron Brooks received the highest number of votes cast for the office of Councilmember and should be elected; and Proposition 401 received a higher number of "yes" votes affirming Ordinance 550; and Proposition 402 received a higher number of "yes" votes approving a franchise agreement between the City of Benson and Sulphur Springs Valley Electric Cooperative, Inc.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Benson as follows:


SECTION 1. That the total number of ballots cast at the general election was 717.

SECTION 2. That Ron Brooks is declared to be elected to the office of Councilmember effective as of the date of the General Election.

SECTION 3. That Proposition 401 passed, affirming Ordinance 550, as passed by the City Council on October 11, 2010.

SECTION 4. That Proposition 402 passed, approving and ratifying the franchise agreement between the City of Benson and Sulphur Springs Valley Electric Cooperative, Inc.
